
The garage entry gate is located on the MLK street side, closest to the Museum and Preservation Park.

Lindsay Barenz, President of the Oakland Roots Sports Club, discussed efforts to establish a training facility for the United States National Soccer team in preparation for the 2031 World Cup.

Robert Rayburn, Bay Area Rapid Transit (BART) Director, provided an update that included matters related to its budget, future financial shortfall, installation of new fare gates, crime reduction, and increased ridership.

Lena Tam, a member of the Alameda County Board of Supervisors, indicated that the board is willing to meet collectively with mayors and city managers to discuss Measure W. She also indicated that Alameda County is conducting workshops on the matter.

Mayor Ezzy Ashcraft provided an update on the Metropolitan Transportation Commission (MTC) activity on the proposed Connect Bay Area Act (SB 63), a regional transportation measure for all five Bay Area Counties.

Mayor Ishii reported on the Alameda County Homelessness Working Group, indicating it is working on revisions to its letter to the Alameda County Board of Supervisors concerning the management of Measure W funding.

Hayward Mark Salinas On behalf of the cities in Alameda County, we would like to express our support of AB 736 which authorizes the Affordable Housing Bond Act of 2026 and places a \$10 billion housing bond on the ballot to fund production of affordable housing and supportive housing.

According to the 2022 Statewide Housing Plan, to meet California's unmet housing needs, the state needs an additional 2.5 million housing units, including 1.2 million for lower-income households. Decades of underbuilding have led to a lack of housing overall, particularly housing that is affordable to lower-income households. The state needs an additional 180,000 new units of housing a year to keep up with demand - including about 80,000 units of housing affordable to lower-income households. By contrast, production in the past decade has been under 100,000 units per year – including less than 20,000 units of affordable housing per year.

Furthermore, the state's homelessness crisis is driven by the lack of affordable rental housing for lower income people. According to the California Housing Partnership's (CHP's) Housing Need Dashboard, in the current market, over 2 million extremely low-income and very low-income renter households are competing for roughly 750,000 available and affordable rental units in the state. Over three-quarters of the state's extremely low-income households and over half of the state's very lowincome households are severely rent burdened, paying more than 50% of their income toward rent each month.

One request would be to stop exclusively using the current Opportunity Maps as the sole indicator for affirmatively furthering fair housing. The use of these maps effectively excludes the entirety of Alameda County, most rural towns and small Following the meeting's conclusion, Vice President González, provided a host city report detailing the City of San Leandro's focus on improving services and quality of life in the City. He discussed the City's culture of volunteerism and neighborhood vitality. He also discussed the City's efforts to reopen a new branch library, establish farmers' markets, improve police services, and reduce crime.

The guest speaker was Howard Chang, Chief Operating Officer for AVA Community Energy, who provided an overview of its services, power sources, service options, and the impact of the recently approved Federal Budget Reconciliation Bill H.R. 1.
